Secretary's Report

The 84th Annual Meeting of the North Central Section returned to the Windy City to phenomenal weather and the political news that Mayor Richard M. Daley was not going to seek reelection. However, the real news in Chicago that week was the highly successful meeting hosted by Dr. Steve and Carrie Siegel. Under the seasoned organization of Dr. Howard Winfield, the academic program was comprehensive with several new additions. There were over 470 registered participants

and the meeting received rave reviews for its academic and social qualities.

The AUA Course of Choice this year was an update on cancer directed by Dr. Sam S. Chang. He was ably assisted in the course by faculty, Dr. Thomas H. Tarter and Dr. James A. Brown. Following the Course of Choice was a new addition to our meeting: live surgery. This was sponsored by Northwestern University and we appreciate the work done by Dr. Chris Gonzalez who performed urethroplasty for stricture disease, and Dr. Robert Nadler who performed the robotic radical prostatectomy. Over 60 members attended this highly interactive and educational program, which will hopefully become a regular part of meetings in the future. Another highlight of the meeting was our Health Policy Panel, which was chaired by Dr. Herbert W. Riemenschneider and featured Congressman Phil Roe, MD, who provided us with a complete review of the process involved in approving the healthcare bill. Members had many questions and the associated panel, along with Congressman Roe, provided much clarity to the process involved in the recently passed healthcare legislation.

Over 300 abstracts were submitted this year and over 227 were presented. They represented a comprehensive coverage of urology. The discussant added a tremendous amount of new information for members. Another new addition this year was member participation. This was incorporated in several of our invited speakers' lectures, along with other aspects of the meeting. This interactive process provided information for those in attendance and the lecturer. The North Central Section Resident Bowl reached a new level with very difficult questions and good organization. The membership was impressed with the knowledge of the residents who participated. It was highly competitive and the scores were quite close, but ultimately a top resident team was identified. The Young Urologist luncheon panel on "Job Hunting What to Look For," had a full room of attendance. We were fortunate to have Dr. Sushil S. Lacy, AUA president-elect, provide an update to the membership from the AUA.

Once again, we attracted an incredible group of invited speakers who are luminaries in the field of urology. These included Dr. Joseph A. Smith, Jr., who participated in panels and also discussed the "Impact of Surgical Approach and the Outcome of Radical Prostatectomy." Dr. Steven K. Wilson updated us on the "Pearls, Perils and Pitfalls of Prosthetic Urology." Dr. Neil H. Baum gave us hints on managing a urology practice and balancing your personal/professional life. Dr. E. Ann Gormley updated us on the surgical management of male

incontinence and complications of mesh in pelvic surgery. In literally every field of urology there are major advances happening at a rapidly increasing pace. The invited lecturers really pushed the envelope on updating us on many of the changes that have occurred since our last meeting in each of their areas of specialty.

The honorary guest this year was Dr. Shlomo Raz, who was President Siegel's mentor and is currently Professor of Urology at UCLA School of Medicine. He is one of the most prominent physicians in the field of female urology and urologic reconstructive surgery. He spent over 30 years at UCLA and pioneered many of the innovations that are the worldwide standard of care in his area of expertise. His honorary lecture was on "Pelvic Pain and Neuromodulation," but he also provided two additional talks during the conference on the repair of vesicovaginal fistula and the use of bowel in urinary tract reconstruction. The honorary lecture was followed by the presidential address by Dr. Siegel, "Intergenerational Urology: A Common Bond." He introduced us to the large number of families that have produced multiple urologists and reaffirms what a positive specialty we have; as many as four generations followed other family urologists into the field.

Although the days were full with the very strong academic program, under the direction of Local Arrangements Chair Couple Dr. Tamra and Todd Lewis, the social events were outstanding. The welcome event featured a wine tasting and heavy hors d'oeuvres in the exhibit hall, which provided ample time for the attendees to visit with the exhibitors who provided up-to-date information on new pharmaceutical and device products. The high attendance was appreciated by the exhibitors, who continue to be an important contributor to the support of our annual meetings. The theme night included a bowling competition that was enhanced by the fine food and drink. President Siegel surprised the officers and state representatives with their own personalized bowling shirts, and although the officers and state representatives looked like professional bowlers, I'm not sure it helped their scores much. The final evening's annual banquet provided an opportunity to socialize together with fine food and a full band with a brass section and associated dancers. Many people were dancing until after midnight.

The Nominating Committee, supervised by the outstanding leadership of Past President Dr. Stephen Nakada, provided the names of Dr. Dennis Pessis for North Central Section AUA President-Elect and Dr. Sheila Gemar for Historian. The membership unanimously approved these positions at the annual meeting. Dr. Peter Knapp ascends to president and Dr. Howard Winfield ascends to the president-elect position. We all owe Howard a huge debt of gratitude for his organizational skills and leadership of our section as secretary for the last three years. I ascend to the secretary position. Special thanks are extended to Dr. Kevin A. Spear, whose three-year term on the board ended at our last meeting. In addition, Dr. Stephen Nakada, immediate past president, moves off of the Executive Committee. We will all miss his sage advice and leadership as he completes seven years of service as an Executive Committee member. Two committee chairs also step down: Dr. Jessica Casey and Dr. James C. Ulchacker, the former our Resident Committee chair and the latter the chair of the Young Urologist Committee. We welcome a new board member, Dr. Mark D. Stovsky from Cleveland. I would also like to welcome Dr. Matthew T. Gettman as the new chair of the Young Urologist Committee and Dr. Aaron J. Milbank as the vice chair, which is also a board position.

The Board approved dropping the \$150.00 registration fee for non-presenting residents at future meetings. The Board also approved a donation to the International Volunteers in Urology this year applying \$8,000 to cover two resident fellowships. Several states have taken advantage of the new North Central Section Visiting Professorship, where the North Central Section covers the honorarium and travel expenses of a North Central Section member that is identified as a visiting professor for the State Societies. We encourage states to take advantage of this new educational program. We continue to look for ways to involve younger members in all facets of our meeting and appreciate suggestions from the Residents and Young Urologist committees.

I appreciate the honor the membership has bestowed on me to assume the Secretary position of the North Central Section. I am following a long line of very successful past secretaries and I will do my best to approach the level of success of my predecessors. I want to reiterate the hard work that Dr. Howard Winfield has done over the last three years. I know we all appreciate his dedicated service. He has moved our organization ahead. I look forward to working with him over the next three years as he remains on the Executive Committee. I also look forward to working with WJ Weiser & Associates, who have done an outstanding job of behind-the-scenes organization to advance our section. One of the high points of this year has been their successful work with industry to raise the support of this meeting equal to the highest support we have ever received in the past. We are extremely lucky to have such an organized group of people that work with Wendy and provide the support so the organization can be so successful. 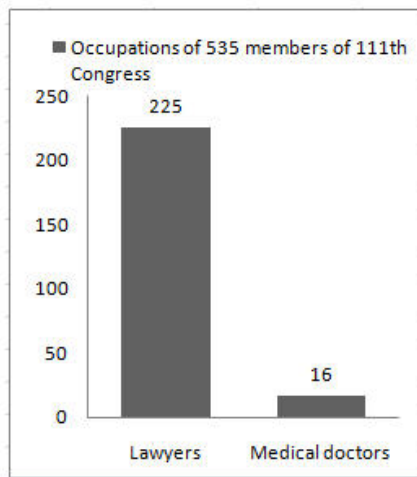

Focus on health reform

At the October 1, 2010 meeting of the North Central Section of the AUA Health Policy Committee, physicians shared a number of challenges they face in their daily practice as a result of state laws and regulations. These ranged from medical liability reform, certificate of need limitations, imaging restrictions, scope of practice incursions and prescription authority. The highlight of this meeting, however, was a highly-informed presentation on federal health reform by Congressman Phil Roe (R-TN).

As one of the few physicians in the House of Representatives, Congressman Roe should have played an active role in the development of what became the Patient Protection and Affordable Care Act. It was a shock, therefore, to learn from the Congressman that when he received the legislation it was a *fait accompli*. Congressman Roe insists that the PPACA's attempts to control provider payments will ultimately limit the availability of physicians and the rationing of

health care. Addressing medical malpractice reform, he countered, would minimize the practice of defensive medicine and thereby slow the growth of health insurance premiums. Unfortunately, Roe wryly asserted, the number of lawyers in Congress far outpaces physicians so the former's interests will nearly always find their way into legislation.



Lawyers have descended upon state capitals throughout the North Central Section as early efforts toward implementation of the PPACA go forward. Only Minnesota, under Governor Tim Pawlenty (R), has thus far refused federal funds in this regard. Even states that are challenging the law, including Indiana, Michigan and North Dakota, accepted grants to study and/or implement federal reform.

Such applications may cease, however, in light of GOP wins in various races for governor and attorney general. Governors and attorneys general-elect in Michigan, Ohio and Wisconsin vowed during the campaign to fight PPACA at every opportunity.

Elections flip NCS states

While GOP gains were predicted throughout the country in 2010 elections, the number of offices and legislative chambers in North Central Section states that switched party stunned observers. Democrats in Minnesota lost 26 of their 87 seats in the House and 16 of their 46 seats in the Senate. In Michigan, House Democrats lost at least 19 of their 66 seats. More predictable "flips" occurred in Wisconsin, where Republicans took control of both chambers. In one race for Governor, results remain "too close to call." As of press time, the Democrat leads the Republican in Minnesota. If this trend continues, the governorship will switch parties.
